The *VI Congreso Nacional De Reconciliación*, to take place Sept. 30—Oct. 2, 2013 in Bogota, Colombia, will gather bishops, pastoral teams, religious communities, and civil society groups to engage in dialogue and analysis on the path to reconciliation and peace. ### **2013 Nansen Refugee Award to Congolese Nun**

Sister Angélique Namaika, a Congolese Roman Catholic nun who has shown exceptional courage and unwavering support for survivors of brutal violence in Democratic Republic of the Congo (DRC), has been selected as the 2013 winner of UNHCR's Nansen Refugee Award, which she will receive on September 30 in Geneva. In north-eastern DRC, the Lord's Resistance Army (LRA) has waged a campaign of violence that has uprooted hundreds of thousands of people. Sr. Angélique works on behalf of the more than 2000 Congolese women and girls who have been kidnapped and terrorized. Of these women, she says, "I will never stop doing everything possible to restore their hope and offer the chance to live again." ### **Colombia: Week for Peace 2013**

The 26<sup>th</sup> annual Week for Peace concluded on September 15 after a series of marches, rallies, meetings and cultural events devoted to a mobilization for peace. The Catholic Church led a pilgrimage of the statue of Our Lady of Chiquinquirá, the patroness of Colombia, to areas throughout the country during the week. The Colombian Episcopal Conference, religious orders, REDEPAZ and other Catholic groups participated. Founded in 1987 in the *Pontificia Universidad Javeriana* in Bogotá, the week for Peace is celebrated in the second week of September and has grown from a regional to a national celebration and movement for peace. ### **Colombia: Letter to Negotiators**

A coalition of Colombian faith-based and peace organizations, including key Catholic actors such as the Colombian Episcopal Conference and Jesuit and Pontifical Universities, sent a [letter](#) to the Colombian negotiating teams in Havana Aug. 30, 2013 focusing on human rights, labor rights, peace and reconciliation. They urge negotiators

to stay at the table until an agreement is reached and conclude by offering to play their part in educating the populace.

### **Mindanao: Bishops Issue Appeal for Peace**

Following recent hostilities that have left at least 53 people dead and thousands displaced, the Catholic bishops in Mindanao called for the government and Muslim rebels to engage in dialogue to find a peaceful solution. In addition, they ask for government and civil society groups to support displaced persons, and plea for the government and rebels, known as the Moro National Liberation Front, to negotiate the release of hostages. ### **Mindanao: Interfaith Council**

After a year of preparation, the Interfaith Council of Leaders-Sulu was formed at the end of August 2013. Following on the success of Christian-Muslim dialogue groups in other regions, this group will work towards the promotion of better understanding and relations between Christians and Muslims in Mindanao. Together the two faith groups will undertake efforts for the common good of the community. [Read more.](#)

### **Myanmar: Archbishop Calls for Respect for Diversity**

Archbishop Charles Maung Bo calls for respect for ethnic and religious diversity as a key element of true peace and freedom. In a [letter published in The Myanmar Times](#), August 23, 2013, he addresses the current situation, including the recent violence against Muslims, and calls for financial assistance for displaced persons and access to those living in camps. "No society can be truly democratic, free and peaceful if it does not respect – and even celebrate – political, racial and religious diversity, as well as protect the basic human rights of every single person, regardless of race, religion or gender."

### **Human Rights Monitor 2012-13: A Report on the Religious Minorities in Pakistan**

The National Commission for Justice and Peace of the Pakistan Catholic Bishops' Conference published its report on religious minorities in June 2013. For the last 15 years, the Commission has been compiling data and analyzing it using a human rights framework. The report looks at such areas as social discrimination, religious freedom, blasphemy laws, crimes against women, and political participation. It concludes with recommendations, "believing in the future Pakistan where everyone can live with peace and have access to justice and rights are respected."
