Critical Time for Peace in Sudan

This is a critical time for peace in southern Sudan as the 2005 peace agreement enters its final year of implementation. National elections were held in April and southerners will vote in a referendum on independence from Sudan next January. This past March, the Sudanese Church Leaders Forum brought together more than 60 leaders from Sudan's Christian churches under the umbrella of the Sudan Council of Churches to promote a unified vision for peace (<http://crs-blog.org/sudanese-church-commits-to-promoting-peace-in-sudan/>). The Sudan Catholic Bishops Regional Conference is playing a prominent role in peacebuilding (<http://scbrc.net/index.htm>), with the support of various Catholic aid agencies, including Catholic Relief Services, which has announced a \$4 million peacebuilding initiative
