### **Religious Leaders Willing to Mediate Negotiations with Lord's Resistance Army**

A conference was held Feb. 2-4 in Kisangani, Democratic Republic of Congo, attended by religious leaders of the areas where the Lord's Resistance Army (LRA) is active: northern Uganda, eastern DRC, southern Sudan and the Central African Republic. At the end of the sessions, a regional committee was established to formulate proposals for possible mediation efforts with the LRA. ### **Statement on Nuclear War**

Archbishop Edwin O'Brien of the United States Conference of Catholic Bishops attended the Global Zero Summit in Paris where he reiterated the Church's support for a global ban on nuclear weapons. Referring to just war doctrine, Archbishop O'Brien indicated that "[n]uclear war-fighting is rejected in Church teaching because it cannot ensure noncombatant immunity and the likely destruction and lingering radiation would violate the principle of proportionality." ### **Release of Report on Religion and US Foreign Policy**

On February 23, the Chicago Council on Global Affairs Task Force on Religion and the Making of U.S. Foreign Policy released a major report on strategies for better incorporating religion into the U.S. foreign policymaking framework.
